#### Who should attend?

Those wishing to attend this training course must be physically fit and not suffering from vertigo or similar conditions or on medication that could affect their safety. Anyone wishing to use a Mobile Elevated Work Platform (MEWP) for this course must hold a current licence to practice in the MEWP type intended for operation.

- Understand the types of pruning and how, and when, each should be applied
- Demonstrate the principles of target pruning and how to apply them
- Prepare machinery and equipment for transport and storage
- Dispose of arisings appropriately.
